- The meeting was facilitated by OIPP Chair Liz Warren. Liz welcomed all members present, and all members introduced themselves.
- **Leadership Team Updates: Liz Warren**
 - The Leadership Team met.
 - The move from meeting in person to conference calls for the Professional Development and Capacity Building Action Group (PROCAP) has caused a significant decline in attendance. These groups are being facilitated by ODH Staff and they need your input to guide the work of the committees. Please consider working on these important projects – the time commitment is minimal.
 - The location for the August 11th OIPP meeting will remain at the Ohio Fire Academy.
 - OIPP has begun a Peer Program for new members. After new member orientation, the new member is connected with a seasoned member for the day. The goal is to make new OIPP members feel welcome and comfortable at their first OIPP meeting, by guiding them throughout the day and providing general information about the coalition. To participate, the seasoned member would meet a new member at the end of New-Member Orientation at approximately 9:50 AM, prior to the start of the 10AM OIPP meeting. New and long-standing members would be partnered for the day according to the Priority Injury Action Groups in which they are interested (Prescription Drug Abuse, Child Injury, or

Older Adult Falls Prevention). The expectation would be for the long-standing OIPP member to act as a resource for the new person by providing information and answering questions through phone calls and emails. Anyone interested may contact Beth Swallow (614) 728.4678.

Violence and Injury Prevention Program (VIPP) Update: Jolene Defiore-Hyrmer

- New ODH staff positions were presented including Tiffany Jamison, Child Injury Prevention Coordinator; Tina Krempasky PDO Public Health Consultant; Kathleen Koechlin, Health Services Policy Analyst/Evaluator; Maggie Frankenberg, Researcher; and Amy Holthusen, Project DAWN Coordinator.
- Prescription drug programs are being expanded. There is a public awareness campaign to raise awareness of Project DAWN and provide Naloxone to high burden counties. Surveillance efforts are being expanded to include EpiCenter chief complaint data to provide counties with more timely data. There is work being done on a community response plan to assist counties in how to use the data.

Infrastructure-Level Groups

Data Action Group (DAG): Alan Wedd

The first DAG webinar will be held on June 2nd, from 1-2PM. There are two presentations scheduled, and everyone is welcome to attend. Information for connecting to the webinars will be sent out prior to June 2nd. The first presentation is by Nicole Schiesler, discussing student drug use:

To increase data driven decision making for prevention programs, PreventionFIRST! implements the Student Drug Use Survey (SDUS) every two years to seventh through twelfth graders in Southwestern Ohio. Nicole Schiesler, Director of Coalition Strategies, will share the 2016 SDUS survey results and trends across the nine cycles of data collection since 2000. The 2016 data comes from a census of 88 public and private schools from 7 Ohio counties. Over 39,000 students completed the SDUS from September of 2015-November 2015.

The second presentation is by Steven Kelley, discussing the changes in Ohio's demographics: -This presentation provides an introduction to the Ohio Development Services Agency website for populations of the state, counties and places. Population Counts, Estimates, and Projections out to 2040 will be reviewed. County Profiles that have data for over sixty variables will be reviewed. County Indicators will show seven years of county level data compared with the 88 counties in Ohio. These numbers are the officially sanctioned numbers for state planning so you want to know where they can be found.

Professional Development and Capacity Building Action Group (PROCAP): Beth Swallow

- 3 subcommittees held conference calls in April 2016.
- ***Member Outreach***
- -Upcoming grant cycle – plan to recruit for members with domestic violence expertise

-Reviewed Mentoring Program. Considered a change to the format to assist new OIPP members. Will implement Peer Program to pair new member with experienced member for the day.

- **Communication**

- -OIPP newsletter was proposed, it would be sent to members and posted to the website. The newsletter could highlight members and use pictures.

- **Professional Development**

- The group is planning to review the 2015 Member Survey to determine the most desired training topics and look at current national topics to identify potential training topics. 3 top desired topics from survey are evidence based practice, grant writing, and injury data
- -Professional development could be offered face to face or by webinar. CEU's could capture a bigger audience. Funding would need to be considered.
- -Identifying speakers for OIPP meetings could be a committee function.
- -A co-chair is needed

- **Injury Prevention Policy Action Group (IPPAG): Nichole Hodges**

- Nichole testified on Senate Bill 157 regarding requirement of bike helmet usage.
- A Graduated Driver's License coalition was developed by AAA. They plan to work on legislation next February
- More policy books are available

Priority Injury Action Groups Reports

Prescription Drug Abuse Action Group (PDAAG) - Allisyn Leppla, Prepared by Judi Moseley

- Geneva Sanford, LISW, Trauma Center, Grant Medical Center – resigned due to increased work responsibilities. We thank Geneva for her leadership with the PDAAG. Allisyn will be new co-chair working with Nicole Schiesler.
- VIPP liaison to PDAAG: To assist with the transition while new VIPP staff are training for their responsibilities, the prescription drug abuse/overdose prevention program at the Cuyahoga County Board of Health will be coordinating the PDAAG and Project DAWN. Allisyn Leppla will be coordinating the PDAAG; Vince Caraffi will be coordinating the Project DAWN calls and Emily Metz will be providing technical assistance to Project DAWN programs and working on a PD toolkit.
- -The Governor's Cabinet Opiate Action Team (GCOAT) issued the third set of opioid prescribing guidelines in January that addressed opioid prescribing for acute pain episodes outside the emergency department and are in the process of rolling out a campaign to educate prescribers about the guidelines. The HC Provider committee will be part of the effort to promote the use of these guidelines across the state.
-Held a conference call on May 4
- PDAAG subcommittees are continuing to work on the following issues:

-**Health Care Provider Education Committee:** working on the promotion of the opioid prescribing guidelines and identifying a guide that clinicians can use to integrate the guidelines in to their practice.

-**Harm Reduction Committee:** Is continuing to promote Project DAWN and other harm reductions programs.

-This committee developed a recommendation for the distribution of naloxone in drug courts that has been sent to the Specialized Docket Section of the Ohio Supreme Court and the GCOAT. Megan Hatta, one of the co-chairs, will be speaking about this recommendation for the Drug Court Commission in June.

-The committee, working with staff at OHMAS, also developed a guidance document on the use of naloxone at treatment centers that has been sent for review at OHMAS. The goal is to have OHMAS distribute this guidance to the treatment centers they fund. The OHMAS leadership is supportive of this recommendation and we are hopeful it will be implemented soon.

-Both of these recommendations were reviewed and approved by the OIPP Leadership Team and they were sent using the OIPP and PDAAG letterheads/logos.

-Held a conference call on April 12.

- Speaker at PDAAG for May meeting: A representative from the Maternal Opiate Medical Support (MOMS) program in Cincinnati spoke.
- General updates related to prescription drug abuse and overdose:
- Project DAWN programs have expanded to 49 programs in 43 counties:
- Naloxone kits for law enforcement: As reported in November, the state budget bill included money for naloxone for law enforcement agencies that can be accessed by county health departments through an account at OHMAS. This program is coordinated by GCOAT & OhioMHAS and continues to grow. However, participation is still not at 100%. Project DAWN staff members are providing most of the training for law enforcement.
- Syringe exchange programs are now permitted in Ohio due to language in the state budget bill that was effective July 1, 2015. There are currently seven syringe exchange programs in the state: Gallia, Montgomery, Scioto, Franklin, Cuyahoga, Cincinnati/Hamilton County, and Middletown/Butler County.
- PDO Legislation in Ohio: Several relevant bills have been introduced. A bill tracker is being updated. It will be presented or distributed.

Action Group Updates

Child Injury Action Group (CIAG): Amanda Kelley

- Membership: 178 members, including 45 new members in 2016!
- Strategic planning – starts today; continues June 14th at Union County Health Department
- Pilot Projects: Awarded just over \$15,000 to 4 agencies
 - Greene County Public Health – Infant Safe Sleep – Task Force Creating and Infrastructure

- University Hospitals Rainbow Injury Prevention Center – Infant Safe Sleep – Hospital Modeling
- University of Dayton – Sports/TBI – Preschool/head start curriculum development
- Nationwide Children’s Hospital – Infant Safe Sleep – Video translation

The CIAG committees are currently working on:

- Bike & Wheeled Sports – signage for parks and schools
- Car Seat Law Revision – law enforcement education through e-OPOTA video
- Teen Driving – GDL Education
- Infant Safe Sleep – Cribs for Kids
- Sports/TBI – student project for gathering youth league contact information

Ohio Older Adult Falls Prevention Coalition: Liz Warren

- The Falls Coalition has awarded 7 pilot projects in the amount of \$30,000. The projects will focus on home modifications, medication reviews, Tai Chi, and Matter of Balance.
- The Infrastructure Committee of the Coalition is working on an online listing of Tai Chi instructors/classes available in Ohio.
- The Conference Planning Committee continues work on the April 7, 2017 conference. Three subcommittees have been formed to provide easier task management. These include Agenda, Marketing, and Fundraising/Sponsorship.
- The Promotions Committee is working on creating materials for members to use that detail what resources are available for fall prevention across Ohio.
- The Coalition will be updating the state plan in upcoming months and will be working with Kent State University on the project.
