

## **Reproductive Health and Wellness Program FY2017 Solicitation**

The Ohio Department of Health (ODH), Bureau of Maternal and Child Health (BMCH) announces the availability of Reproductive Health and Wellness Program (RHWP) competitive grant funds to comprehensively address issues of reproductive health and wellness with a focus on populations in greatest need and identified priorities. Funds will be available for applicants to ensure there is an organized effort to improve the overall health and well-being of women and men by promoting healthy lifestyles and encouraging the establishment of a reproductive life plan.

For more information and to obtain a grant application packet:

1. On the ODH home page click on "Grant/Contract";
2. From the next page (Funding Opportunities), click on "ODH Grants";
3. From the ODH Grants page, click on "Grant Request for Proposals", this will give you a pull down menu with current RFP's by name;
4. Select and highlight the Reproductive Health and Wellness and click "Submit". This process invokes Adobe Acrobat and displays the entire RFP. You can then read and/or print the document as desired.

All interested parties must submit a Notice of Intent to Apply for Funding (attached), no later than **Wednesday, January 20, 2016**, to be eligible for these funds. All applications and attachments are **due by 4:00 p.m. on Monday, February 22, 2016**. Electronic applications received after Monday, February 22, 2016 will not be considered for funding. Faxed, hand-delivered or mailed applications will not be accepted.
